CANDLES is a 501(c)(3) non-profit organization that was founded in 1995 by Holocaust survivor Eva Mozes Kor in honor of her twin sister, Miriam. Our mission is to contribute to the empowerment of the world through hope, healing, respect, and responsibility by shining a light on the story of the Holocaust, Eva Kor, the Mengele twins, and other survivors.

Founded originally as CANDLES, Inc., an organization dedicated to finding surviving Mengele twins around the world, CANDLES has grown into a world-wide movement dedicated to engaging all people in our mission, fostering conversations about important local and global topics, and preserving survivor testimony for future generations.

About Eva Kor:

Eva Mozes Kor passed away at age 85 on July 4th, 2019. Recipient of the 2017 Sachem award, the highest honor in the state of Indiana, Eva was a survivor of the Holocaust, a forgiveness advocate, and a revered public speaker. With the driving message of "never give up" in mind, Eva emerged through a life filled with trauma as a brilliant example of the power of the human spirit to overcome. She was a community leader, a champion of human rights, and tireless educator of young people. Even in her eighties, Eva traveled across the United States and Europe to share her message, in addition to leading hundreds of people on a journey to Auschwitz each year. Eva was one of the few surviving twins who shared her personal account of the medical experiments supervised by Nazi doctor Josef Mengele at Auschwitz.

In addition to the importance of her account of the Holocaust from a historical perspective, Eva's life lessons and message of survival and forgiveness have touched the lives of thousands of people. In 1995, Eva chose to forgive the Nazis. She decided that they would no longer have power over her life. She described forgiving the Nazis as an act of self-healing, self-liberation, and self-empowerment; forgiveness is not about the perpetrator, and it is not about forgetting. It is one step toward repairing the world by helping victims free themselves from perpetrators and remove anger and hatred.

Eva is one of thirteen survivors featured in Dimensions in TestimonyTM, a new interactive technology created by USC Shoah Foundation to preserve survivor testimonies and continue the dialogue between Holocaust survivors and learners far into the future. Her story is documented in the award-winning film *Forgiving Dr. Mengele* and the popular young adult book *Surviving the Angel of Death: The True Story of a Mengele Twin in Auschwitz*. Her story of forgiveness is also recounted in the book *The Power of Forgiveness*. In April 2018, Eva's story premiered as the subject of a feature-length documentary, $Eva\ A-7063$.

In 1995, Eva opened CANDLES Holocaust Museum and Education Center in Terre Haute, IN. The only Holocaust museum in Indiana, CANDLES is also the only organization in the world dedicated to the memory of the twin victims and survivors of medical experimentation at Auschwitz. Thousands of people, including many school groups, have visited CANDLES since it opened. Eva's account of her survival of the Holocaust offers many relevant lessons on the dangers of hate speech and prejudice, and the importance of being an informed citizen. Eva's message of healing reaches across the globe and across social, economic, and cultural boundaries.



About CANDLES, Walter Sommers and Eva Kor (cont.)

About Walter Sommers:

Walter Sommers is a CANDLES' docent, WWII veteran, and Holocaust survivor. He celebrated his 100th birthday last winter and Mayor Duke A. Bennett of The City of Terre Haute declared Dec. 29, 2020, to be Walter Sommers Day, in honor of the momentous milestone. Walter was born in Frankfort, Germany in 1920. By 1937, Walter's parents realized that with the growing antisemitism they needed to leave Germany and began searching for a relative who could sponsor their immigration to the United States. Although they were able to locate a distant cousin, he was not able to provide them with the financial support. Walter's family witnessed Kristallnacht firsthand. The family's specialty shops which sold cholocalate, wine, and coffee, were destroyed and Walter's father was taken to Buchenwald concentration camp. Fortunately, Walter's father was released from Buchenwald after only one month and the family learned that the Nazi officials would allow them to leave Germany if they sold their family business and turned all of the profits over to the government. Walter's family agreed to these terms and left for the United States in January of 1939. Walter had other family members who were not able to emmigrate, who perished in the Holocaust. Walter continues to share his story and his unique perspective on history with visitors at the museum, citing the Treaty of Versaille as the important catalyst for the Holocaust and WWII.

Guidelines for Participation

General Guidelines:

- Only one participant per registration form is allowed.
- Each participant will read and submit, either electronically or in writing, an agreement that releases CANDLES Holocaust Museum and Education Center from liability to his/her person and belongings while on the trip.
- All participants under 18 years of age must be accompanied by an adult. Due to the graphic nature of some content on this trip, caution is recommended for participation of children age 14 and under. Travelers under age 10 are not permitted on this trip.
- All participants understand that CANDLES Holocaust Museum and Education Center offers this trip as educational programming and is not a travel agency.

Participants:

- CANDLES Holocaust Museum and Education Center reserves the right to refuse participation in its domestic and international trips to anyone who might present a physical, mental, or emotional threat to other participants/staff.
- All participants may be asked to undergo a limited criminal history background check from their state of residence and Indiana at their own expense.
- Trip participants are not allowed to use their access to other group members as a way to sell or solicit goods, products, or services to or from other group members.
- All participants are asked to complete and submit a confidential medical form (Sections A, B, and C). A physician's release for travel (Section D) may be required depending on the participant's medical conditions.

Registration:

- To confirm your registration and secure your spot on this trip, a **non-refundable deposit of \$200** per person must be paid/submitted. **Your spot will not be guaranteed until your deposit has been received by CANDLES**.

- Your full trip balance is to be paid in full by July 5, 2021.

Cancellation Policy:

- All deposits are nonrefundable
- Prior to July 5, 2021 CANDLES retains deposit but refunds all other payments, after July 5, 2021 CANDLES retains deposit and refunds 50% of remaining balance
- All merchandise sales are nonrefundable.

Drug Policy:

• The use of illegal drugs and/or underage drinking is strictly prohibited at any time.

- For updates to the itinerary or requests for information, CANDLES staff will use the contact information you provide. Registrants are asked to respond in a timely manner to all communications from CANDLES staff.

Accommodations:

- Rooms can accommodate a maximum of two (2) people. A single/private room is available on a limited basis at an additional cost of \$95 a night.
- If you are meeting the group at the Westin Hotel in Kansas City with a car, there will be an additional parking fee and CANDLES will need to be notified in advance of the need for a parking pass.

Travel Arrangements:

- Tour bus transportation through Turner Coach Buses will be provided at 35 people maximum on a 54 passenger bus from Terre Haute, IN to the Westin Hotel in Kansas City, Missouri
- Participants may choose to join the bus in Saint Louis, Missouri by meeting at the arranged time and location at the Saint Louis Lambert International Airport.
- Participants not taking the bus with CANDLES will submit their travel arrrangements in advance for scheduling purposes.
- Participants not arriving and/or departing Kansas City with CANDLES are responsible for their own transporation to and from the hotel.

Media and Photos:

CANDLES Holocaust Museum and Education Center's COVID-19 Liability Release Waiver

WAIVER of LIABILITY - The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and possibly by contact with contaminated surfaces and objects or in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are unknown, and there is no known treatment or cure for COVID-19. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death.
